## **GENERAL PROVISIONS**

AS-814A DT9621 (rév. 2024-03)

548. Consent provided for in this chapter shall be given in writing and before two witnesses. The same rule applies to the withdrawal of consent.

## **CONSENT OF THE ADOPTED PERSON**

557. A person who has given his consent to adoption may withdraw it within 30 days from the date it was given. The child must then be returned without formality or delay to the person who has withdrawn his consent.
